**LEGAL NOTICE SENT TO THE DIRECTOR, NATIONAL INVESTIGATING  
AGENCY (NIA) NEW DELHI, BY ADVOCATE OF SHRI INDRESH KUMAR**

Late Shri Chaman Lal C/O Keshav Kunj Jhandevalan New Delhi. I hereby  
serve you with this legal notice as under:**

The occasion for this notice is the programme telecasted by Times Now on 1<sup>st</sup> August 2011 around 18:47 hrs onwards, which talks of his alleged impending arrest by NIA. Quite obviously this news is planted by the NIA to begin a media trial and vitiate the atmosphere for justice. You instead of using arrest as a tool of investigation are abusing it for political ends. The decision is obviously guided by political expediency rather than necessity or justification. The utter want of good faith is apparent in the use of media and reveals it as a part of political trickery. Violation of Art.21 is apparent in this misconduct and the exercise is despairing one by a beleaguered government fighting the taint of corruption and


using every means to distract attention from its sordid wrong doings. There is no independent application of mind on the issue but subservient compliance to executive fiat for partisan political purposes. The very credibility of NIA is now suspect and its activities are obviously not circumscribed by law or legitimacy. There is no reason or justification for the threatened arrest except the sheer power to affect it without the accompanying responsibility to account for it.

The leaks both to print or electronic media show that the government is using the NIA for political propaganda and if this threat is infact implemented it would be clear instance of targeted malice not only against Shri Indresh Kumar but also the arbitrary and capricious misuse of power with the specific intent to injure him and will wrong fully deny him all constitutionally guaranteed protections and you will remain liable for this misuse of power and legal action taken against you by my client.
